### Investment Objective

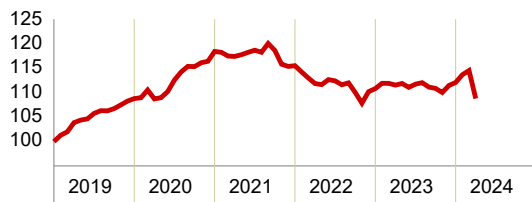

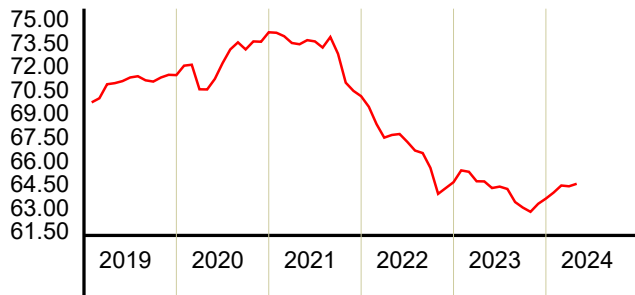
