Investment Objective

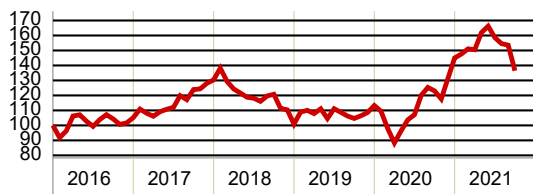

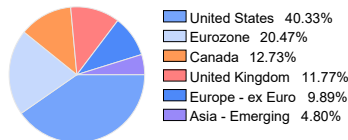

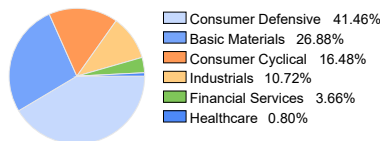

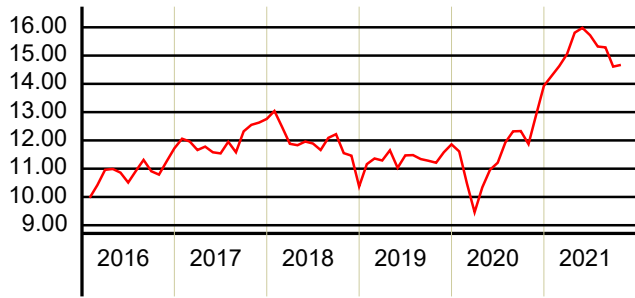
