Investment Objective

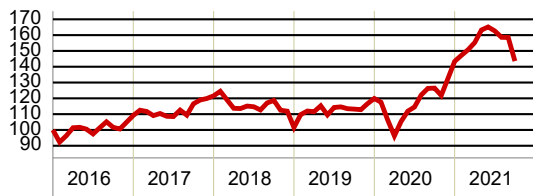

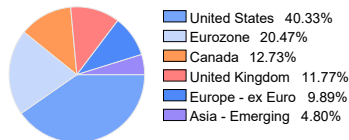

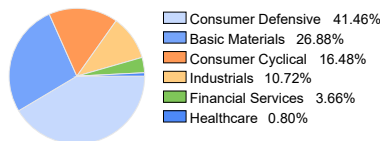

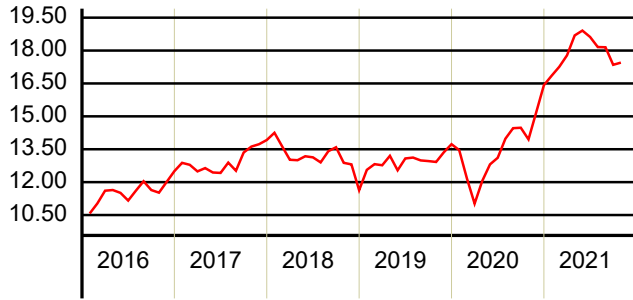
