### Investment Objective

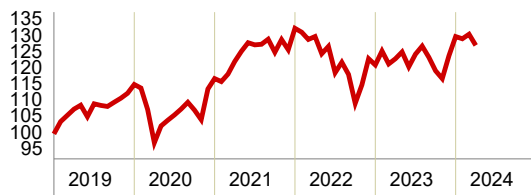

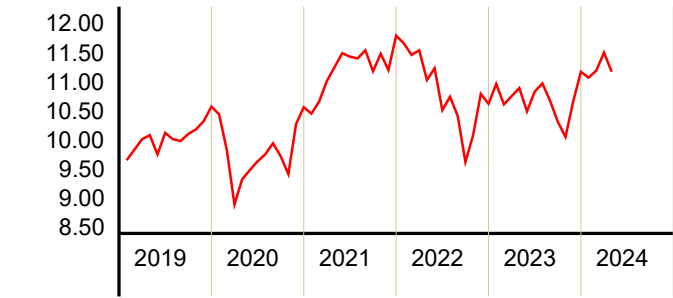
