#### Investment Objective

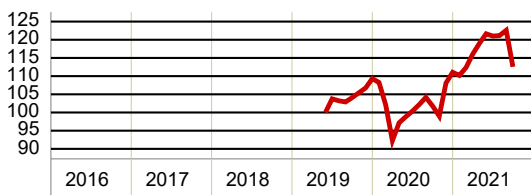

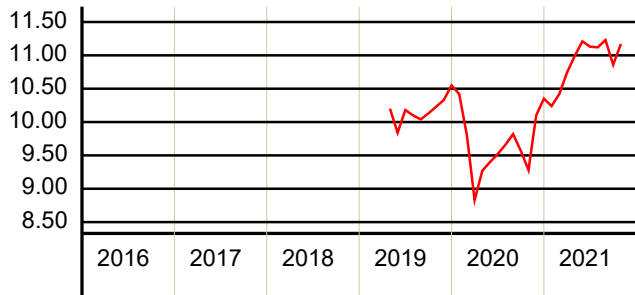
