Investment Objective

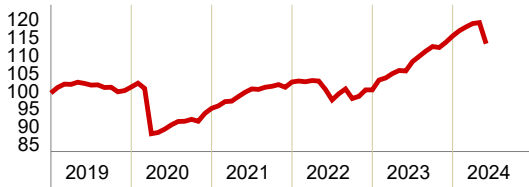

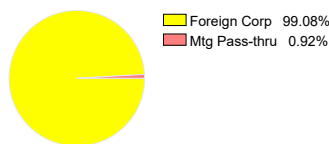

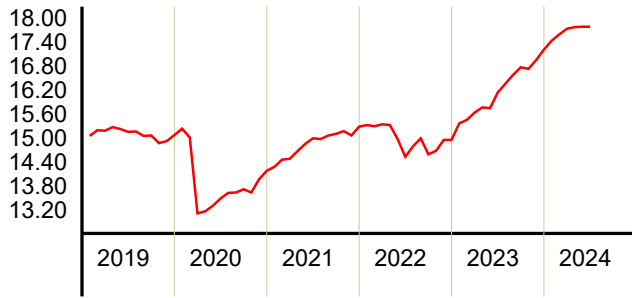
