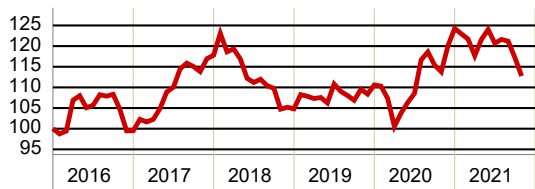

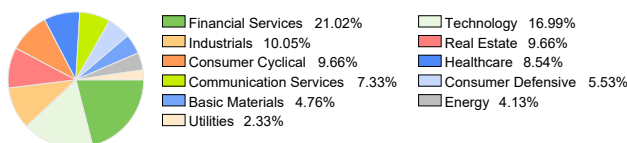

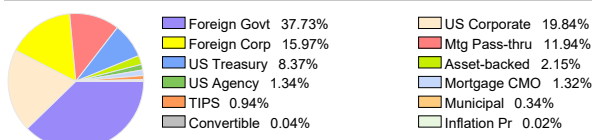
Equity holdings geographical allocation

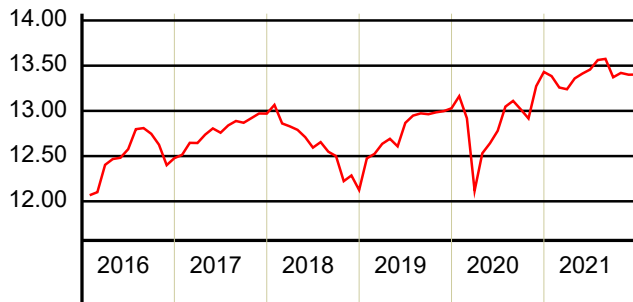
