Investment Objective

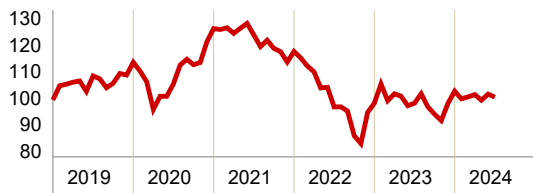

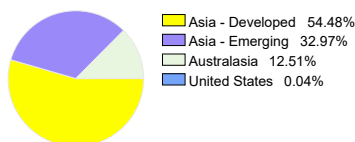

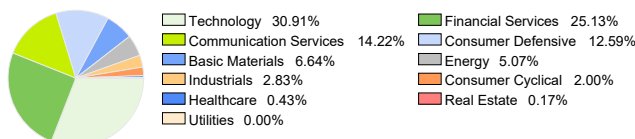

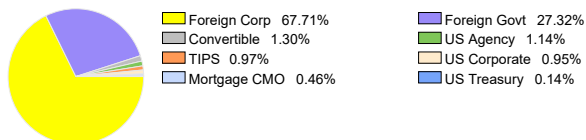
Equity holdings geographical allocation

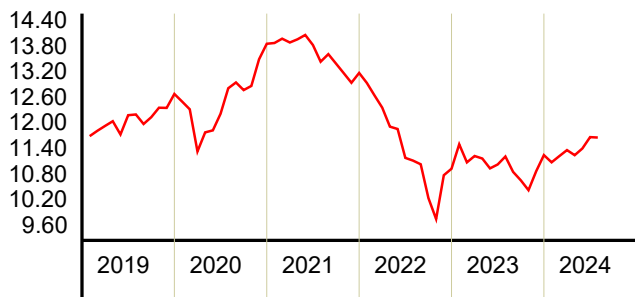
